

## Privacy statement

### Article 1. Definitions

- 1.1 In this Privacy Statement the following definitions are used:
- a. User: the User of this Privacy Statement:
    1. STOFZUIGERMARKT B.V., registered at (3208 KC) Spijkenisse, Kelvinweg 7, registered with the Chamber of Commerce under "KvK" number 37073634;
    2. VARIANT BENELUX B.V., registered at (3208 KC) Spijkenisse, Kelvinweg 7, registered with the Chamber of Commerce under "KvK" number 24309627;
  - b. Contracting Party: the legal entity or natural person acting in the practice of his profession or operation of his business, which places an order with User;
  - c. Website: the websites [www.stofzuigermarkt.nl](http://www.stofzuigermarkt.nl) and [www.variantinternational.com](http://www.variantinternational.com) that are operated by User and through which Contracting Party can order Products from User;

### Article 2. Data

- 2.1 Conscientious use of data is essential to User. In processing data User acts in accordance with the applicable legislation and regulations.

### Article 3. Data processing purposes

- 3.1 The data of Contracting Party collected by User include: company name, contact person, address, email address and telephone number.
- 3.2 User collects and processes the data for the following purposes:
- a. handling requests for offers;
  - b. delivery of the Product ordered by Contracting Party from User, at the address provided by Contracting Party;
  - c. management of customer relations with Contracting Party;
  - d. contacting Contracting Party in connection with the performance of the Agreement entered into by and between User and Contracting Party;
  - e. looking into a question and/or complaint of Contracting Party;
  - f. keeping Contracting Party informed of news about and/or offers and/or new products of User.

### Article 4. Sending digital newsletters

- 4.1 User has the right to send to Contracting Party newsletter containing advertising and/or information on products that are identical with or similar to the products which Contracting Party has ordered from User, in case, during the placing of the order respectively conclusion of the agreement, it was pointed out to Contracting Party that newsletters may be sent to Contracting Party's email address and Contracting Party, during the placing of the order respectively the conclusion of the agreement, was given the option to indicate that it does not wish to receive any newsletters.

### Article 5. Right to object

- 5.1 Contracting Party has the right to object to the processing of its data for direct marketing purposes.
- 5.2 Contracting Party can object in the following ways:
- a. by sending an email to User with the request to remove its email address from the mailing list of User;
  - b. by clicking the link in the email containing the newsletter, to indicate that Contracting Party opts against receiving such newsletters.
- 5.3 In each digital newsletter sent to Contracting Party, Contracting Party is informed of the possibility to opt against receiving the newsletters.
- 5.4 In case Contracting Party objects to the processing of its data for direct marketing purposes, said processing will be terminated immediately.

### Article 6. Provision of data to third parties

- 6.1 User will not provide data of Contracting Party to any third parties unless one of the exceptions referred to in article 6.2 applies.
- 6.2 User is allowed to provide data of Contracting Party to a third party:

- a. in case Contracting Party has expressly approved of that;
  - b. by virtue of a legal provision or in case of a legal procedure;
  - c. to protect the rights or property of User;
  - d. to prevent a crime or to protect national security;
  - e. in case of suspicion of fraud or other illegal activities;
  - f. if necessary for the performance of the Agreement and/or delivery of the Product ordered;
- 6.3 User may also engage other enterprises in order to perform services on behalf of User. Examples of this are processing payments and shipping of the order. They need access to data of Contracting Party in order to perform their services but may not use these data for other purposes.

**Article 7. Security precautions**

- 7.1 In order to prevent access to data of Contracting Party by unauthorized persons User has taken various security precautions including precautions against unauthorized access, use, modification, unlawful and unintentional destruction and unintentional loss of data.

**Article 8. Correcting data**

- 8.1 Upon request User will give Contracting Party access to all information of Contracting Party managed by User. Further User offers Contracting Party the possibility to have any incorrect information of Contracting Party managed by User corrected or deleted. Contracting Party may contact User for inspection of the above-mentioned information or modification or deletion of the data of Contracting Party.

**Article 9. Modifications**

- 9.1 User reserves the right to unilaterally modify this Privacy Statement. Modifications of or additions to the Privacy Statement are published here. User advises Contracting Party to regularly check the Privacy Statement.
